

**THE JACK LINK'S QUEST FOR CASH SWEEPSTAKES**  
**OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.**

The Jack Link's Quest For Cash Sweepstakes ("Sweepstakes") is sponsored by Link Snacks, Inc. ("Sponsor"), One Snack Food Lane, Minong, WI 54859 and is administered by Prize Logic, LLC, ("Administrator"), Two Towne Square, Suite 200, Southfield, MI 48076.

1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins on July 8, 2022 at 12:00 PM Eastern Time ("ET") and ends on September 30, 2022 at 11:59:59 PM ET ("Sweepstakes Period"). The Sweepstakes includes a grand prize drawing ("Grand Prize Drawing") that runs the entire length of the Sweepstakes Period, a Walmart pool ("Walmart Pool") that runs the entire length of the Sweepstakes Period, and includes twelve (12) entry periods (each an "Entry Period") as outlined in the chart below:

Non-winning entries will not carry forward into subsequent Entry Period drawings. The Administrator's computer is the Sweepstakes official clock.

2. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of the fifty (50) United States (including the District of Columbia) who are at least eighteen (18) years old at the time of entry. Employees of Sponsor, Administrator, Groundspeak, Inc., DBA Geocaching ("Groundspeak"), and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Sweepstakes Entities") and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited or restricted by law.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. For purposes of the Sweepstakes, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Boxes will be allowed), city, state, and zip code. Upon the successful submission of the registration information, an entrant will receive one (1) entry into the applicable Entry Period drawing and one (1) entry into the Grand Prize Drawing. **Limit:** Entrant may enter via the Website one (1) time per Entry Period during the Sweepstakes Period. Entrant will only receive an entry into the Grand Prize Drawing one (1) time during the Sweepstakes Period.

**NOTE:** During the Sweepstakes Period, an entrant may receive a link to the Website by scanning the QR code on select Sweepstakes print advertising. An entrant may center the QR code in the camera and scan the QR code. Once completed, the entrant will receive a link to the Website, and may follow the steps noted above to participate enter the Sweepstakes. **An entrant cannot participate solely by scanning the QR code.**

**B. Post A Photo of A Trackable or Jack Link's Logo:** During the Sweepstakes Period, an eligible entrant may log in to the Geocaching.com website ("Geocaching Website") and try to locate a trackable ("Trackable") in a geocache on the Jack Link's promotion page at [www.geocaching.com/jacklinks](http://www.geocaching.com/jacklinks). Using the Geocaching Website is subject to the Geocaching.com [Terms of Use](#), [Privacy Policy](#), and [Disclaimer](#). Once entrant finds a Trackable, he/she must take a photo of the Trackable. After finding a Trackable, the entrant must place the Trackable in the same or a different geocache for others to find. For more information on Trackables, visit [www.geocaching.com/track/](http://www.geocaching.com/track/). To participate without finding a Trackable, an entrant may take a photo of the Jack Link's logo located in the Appendix of these Official Rules ("Logo"). Once entrant has a photo of either a Trackable or the Logo, he/she must:

- i. Sign into his/her Twitter or Instagram account (entrant may create a Twitter or Instagram account for free if he/she does not already have one);
- ii. Become a follower of @Jacklinks on Twitter or @jacklinksjerky Instagram (if not already following @Jacklinks on Twitter or @Jacklinksjerky on Instagram). There is no charge to sign up for Twitter or Instagram or to follow @Jacklinks on Twitter or @Jacklinksjerky on Instagram; and
- iii. Compose a new Tweet or Instagram post sharing the photo of either a Trackable or Logo, including the hashtags "#JackLinksQuest, and #Sweepstakes" and tag @Jacklinks on Twitter or @Jacklinksjerky on Instagram to receive one (1) entry into the applicable Entry Period drawing and one (1) entry into the Grand Prize Drawing. Entrant will only receive an entry into the Grand Prize Drawing one (1) time during the Sweepstakes Period.

**Entry Limit:** There is a limit of one (1) entry per platform per person per Entry Period. If more than one (1) entry per platform per person per Entry Period is received from the same social media account, person, telephone number and/or e-mail address the entries may, at the Sponsor's sole discretion, be disqualified. Entrants are prohibited from using more than one (1) Twitter or Instagram account or multiple identities. If it is found or suspected that an entrant is using more than one (1) Twitter or Instagram account or

To participate without finding a Trackable, an entrant may take a photo of the Jack Link's logo located in the Appendix of these Official Rules ("Logo"). Once entrant has a photo of either a Trackable or the Logo, he/she must:
- i. Sign into his/her Twitter or Instagram account (entrant may create a Twitter or Instagram account for free if he/she does not already have one);
  - ii. Become a follower of @Jacklinks on Twitter or @jacklinksjerky Instagram (if not already following @Jacklinks on Twitter or @Jacklinksjerky on Instagram). There is no charge to sign up for Twitter or Instagram or to follow @Jacklinks on Twitter or @Jacklinksjerky on Instagram; and
  - iii. Compose a new Tweet or Instagram post sharing the photo of either a Trackable or Logo, including the hashtags "#JackLinksQuest #Sweepstakes" and "#Walmart" and tag @Jacklinks on Twitter or @Jacklinksjerky on Instagram to receive one (1) entry into the applicable Entry Period drawing and one (1) entry into the Walmart Pool. Entrant will only receive an entry into the Grand Prize Drawing one (1) time during the Sweepstakes Period.

**Entry Limit:** There is a limit of one (1) entry per platform per person per Entry Period. If more than one (1) entry per platform per person per Entry Period is received from the same social media account, person, telephone number and/or e-mail address the entries may, at the Sponsor's sole discretion, be disqualified. Entrants are prohibited from using more than one (1) Twitter or Instagram account or multiple identities. If it is found or suspected that an entrant is using more than one (1) Twitter or Instagram account or multiple identities to participate in the Sweepstakes, then that entrant, in Sponsor's sole discretion, may not be eligible to win a prize.

Entries will be deemed made by the authorized account holder of the Twitter or Instagram account the entry is submitted from at the time of entry. The "authorized account holder" is the person who is assigned to the Twitter account or Instagram by the online service provider. An entrant must have a non-private Twitter account or Instagram account to enter the Sweepstakes and must be a follower of @Jacklinks on Twitter or @Jacklinksjerky on Instagram until October 30, 2022 for potential winner notification purposes to be eligible to win/claim a prize. - Entry must be an original work;

- Entry cannot be sexually explicit or suggestive, violent or derogatory of any ethnic, racial, gender, religious, professional or age group;
- Entry cannot promote illegal drugs, tobacco, firearms/weapons (or the use of any of the foregoing), any activities that may appear unsafe or dangerous, or any particular political agenda or message;
- Entry cannot describe or depict any illegal activity or violation of any state or federal law;
- Entry must not include any personally identifiable information (full name, e-mail address, telephone number, etc.);
- Entry must not contain, facilitate, reference or use material that contains prohibited content which shall include, but is not limited to, content that promotes, suggests, or encourages:

**4. RANDOM DRAWING:** On or around October 3, 2022, the Administrator will randomly select one (1) potential grand prize winner from all eligible entries received in the Grand Prize Drawing and on or around each drawing date indicated in the chart above in Section 1 the Administrator will randomly select one (1) potential first prize winner from all eligible entries received for each Entry Period for a total of twelve (12) potential first prize winners. On or around each drawing date in the indicated in the chart above in Section1, the Administrator will randomly select one (1) potential winner from among all eligible entries received for the Walmart Pool for each Entry Period, for a total of twelve (12) potential Walmart Pool prize winners. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

**5. PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:**

**A. Grand Prize (1):** The grand prize is \$10,000 ("Grand Prize"). No more than one (1) Grand Prize will be available in the Sweepstakes. The ARV of the Grand Prize is \$10,000.

**B. First Prizes (12 total; 1 per Entry Period):** Each first prize is Jack Link's for a one (1) year awarded as one (1) \$1,200 Jack Links gift card to be used on the Jack Link's website (each a "First Prize"). Terms and conditions of gift card apply; gift cards expire 8/31/23 and items purchased can only be shipped within the United States. No more than twelve (12) First Prizes, one (1) per Entry Period, will be available in the Sweepstakes. The ARV of each First Prize is \$1,200.

**C. Walmart Pool Prizes (12 total; 1 per Entry Period):** Each Walmart Pool prize is a \$500 Walmart gift card (each a "Walmart Pool Prize"). Terms and conditions of gift cards apply and are available at Walmart.com/giftcardterms. No more than twelve (12) Walmart Pool Prizes, one (1) per Entry Period, will be available in the Sweepstakes. The ARV of each Walmart Pool Prize is \$500.

**D. Total ARV:** The total ARV of all prizes is \$30,400.

**E. Odds of Winning:** The odds of winning the Grand Prize depend on the number of eligible Sweepstakes entries received in the Grand Prize Drawing during the Sweepstakes Period and odds of winning a First Prize depend on the number of eligible Sweepstakes entries received for each Entry Period. Odds of winning a Walmart Pool Prize depend on the

number of eligible Sweepstakes entries received for the Walmart Pool for each Entry Period.

**F. General Conditions:** There is a limit of one (1) Grand Prize, one (1) First Prize, and one (1) Walmart Pool Prize per person. In no event will more than one (1) Grand Prize, twelve (12) First Prizes, one (1) per Entry Period, and twelve (12) Walmart Pool Prizes, one (1) per Entry Period be awarded. If, for any reason, more prize notifications are sent (or more claims are received) than the number of prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of prizes through a random drawing from among all eligible prize claims received.

**6. HOW TO CLAIM A PRIZE:** The potential winners are subject to verification of eligibility and compliance with these Official Rules. After each random drawing, Administrator will notify the potential winner via e-mail at the e-mail address provided at the time of registration or via Direct Message on Twitter from @Jacklinks or Instagram from @Jacklinksjerky (depending on potential winner's method of entry). The potential Grand Prize and First Prize winners will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited) and any other requested documents within five (5) calendar days from the date of attempted notification or the prize may be forfeited in its entirety and awarded to an alternate winner, at the Sponsor's sole and absolute discretion. Failure to provide all required information and a signature on the documents within the stated time period may result in forfeiture of a winner's right to claim his/her prize, and may result in the prize being awarded to an alternate winner, if time permits. If a potential winner is disqualified, found to be ineligible or not in compliance with these Official Rules, declines to accept a prize, the respective prize may be forfeited. If a prize is forfeited, the prize may be awarded to an alternate Winner, selected in a random drawing from among all remaining eligible entries, as determined by Sponsor in its sole discretion. If, after a good-faith attempt, Sponsor is unable to award or deliver a prize, the prize may not be re-awarded. Upon verification of eligibility, the Grand Prize winner will be contacted to make arrangements for the Grand Prize and each First Prize will be e-mailed to the winners at the e-mail address provided at the time of entry and the Walmart Pool Prizes will be e-mailed to the winners at the e-mail address provided at the time of entry. Any portion of a prize not accepted by winner will be forfeited. Each winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for his/her prize won. Sponsor will issue an IRS Form 1099-MISC for the each winner of a prize with an ARV of \$600 or more. All other costs and expenses not expressly set forth herein shall be solely each winner's responsibility. The prizes will only be awarded to verified winners.

Sponsor will attempt to notify each potential winner as set forth above, but Sponsor is not responsible for any undelivered e-mails, including without limitation e-mails that are not received because of a winner's privacy or spam filter settings which may divert any Sweepstakes e-mail, including any winner notification e-mail, to a spam or junk folder. Prizes that are unclaimed, unredeemed, or returned as undeliverable will not be awarded. Prizes are non-transferable and no prize substitution, exchange or cash equivalent will be allowed, except by Sponsor, who reserves the right to substitute a prize of equal or greater value in case of unavailability of the prize or force majeure, at Sponsor's sole and absolute discretion. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JAMS IN ACCORDANCE WITH ITS ARBITRATION RULES**

AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF (“JAMS RULES”). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN.
